WOMEN'S CLUB

Seven of these lovely ladies made 60 loaves of Pulla/Nisu in September. All was sold in 2 days netting a profit for the FCA of about \$130. We have been asked to organize more formally. We still do not have a Chairman, but Edith Raski gratiously accepted the position of Secretary.

Pulla/Nisu will again be baked on Thursday, October 26 at 10 a.m. It will be saved for the Bake Sale at the Scandinavian Bazaar on November 11.

Our ambitious ladies want to bake again on Thursday, November 9 at 10 a.m. This time it will be Christmas Tarts and Rieska. If you want to learn how to bake these Finnish specialties, plan to join us as you are very welcome.

FINLAND TODAY

First, it is the 100th anniversary of Finnish women having the right to vote and to hold a seat in the Parliament. On October 1st, 1906, Finnish women were granted the right to vote, becoming only the second country in the world to do so, New Zealand was the first. But, the following year, 1907, Finland became the first country in the world to have women in the Parliament as 19 women were elected.

The optoelectronic materials supplier, Braggone, of Oulu Finland has announced a new product line called LUXONE. This new material will enable manufacturers of flat panel TV displays, and mobile communications devices, cell phones for example, to be much brighter, sharper, use less power and cost less to produce.

For several years Braggone has been collabrating with one of the top research facilities in the world, the VTT Technical Research Center in Finland, and this is another fruit of their work together.

Another Finnish research facility, CSC Finland, the Finnish IT center for science, is acquiring a new top of the line super computer, code named the Hood, from the global leader in super computers, Cray Inc. The new computer will be able to process over 70 terflops (70 trillion floating point operations per second). CSC Finland will use the new system for research in areas such as physics, chemistry, nanotecnology, applied mathematics and engineering.

And speaking about research, the amount of money spent in research in Finland went up again last year. Last year 5.5 billion euros were spent for research, up by 220 euros over the previous year. Of the research money, 71% of it came from private industry.

Finland's oil refining company, Neste Oil, aims to become the world's leading biodiesel producer. Neste plans to invest billions of euros in building new biodiesel production facilities in Europe, with atleast two of them in Finland. Currently Neste is constructing a plant in Porvoo, in southern Finland.

Biodiesel can be produced from vegetable oil such as canola, soy, palm and from animal fats.

The European Union has said that by 2010, 5.75% of the European transportation vehicles should be powered by renewable fuels.

The World Economic Forum has again named Finland as one of the world's most competitive economies. Switzerland was number one on the list followed by Finland, Sweden, and Denmark. Said a spokesman for the Forum, "Countries like the Nordics, that are investing heavily in education, are likely to see rising levels of income per capita, growing success in reducing poverty and an increasing ability to establish a presence in the global economy".

Finland's trade surplus has continued to grow. As the figures from August have come in, they showed that Finland's surplus was 420 million euros compared to 311 euros last year. In August Finland's exports were 5.075 billion euros and imports were 4.655 billion euros.

Two years ago Nokia employed 450 people in its Chennai, India facility. Since opening its new facility in Chennai in January 2006, Nokia's employment has reached 5,500. And in the first 8 months of opening the plant, it has produced 10 million mobile phones.

The Sibelius Concert Hall in Lahti has been named the 5th best concert facility in the world. Number one on the list was the London Wigmore Hall. The Walt Disney Hall in Los Angeles was 6th, tops in the U.S.

Finland's largest department store, Stockmann is building a shopping center in the central part of St. Petersberg, Russia. The store should completed by 2008.

Finland's Amin Asikainen defended his middle weight boxing European Championship by out pointing Alexander Sipos of Germany. Asikainen is undefeated in his 19 professional fights, winning 14 of them by knock-outs.

The NHL's Nashville Predators have named defenseman Kimmo Timonen as its captain. Other Finnish captains in the National Hockey League are Saku Koivu of the Montreal Canadiens and Olli Jokinen of the Florida Panthers.

In other hockey news, the media has forecast the Calgary Flames to win this year's Stanley Cup, mainly because of its goalie, Finland's Miikka Kiprusoff. The Hockey News magazine has named Kiprusoff the best player of any position in the NHL.

And finally,

FROM THE FCA LIBRARY

History was not one of my favorite subjects in school, but now I find that it can be very interesting reading when it is about the land of our forefathers. Here are a few suggestions if you are of the same mind:

A SHORT HISTORY OF FINLAND, by Fred Singleton. This is a revised and updated version of an earlier book by Singleton published in 1989. The jacket calls it "the most successful study of Finland in the English language." Its 177 pages are highly readable and cover Finland's history from the final melting of the ice cap around 8000 B.C. to the present. This is a book you can read in parts if you want to, for it is neatly divided into chapters covering Finland under Sweden, under Russia, independent Finland, wartime years, postwar Finland, political development, and economic development. This is in the Finnish history section, call number 947.1 Si.

NEITHER STALIN NOR HITLER by Jukka Tarkka. Finland faced a real dilemma in 1939-40 when the country was invaded by the Soviet Army. When neither Scandinavia nor the Western powers were able to come to her aid, she had to accept it from the only source available, the Germans, even though the Finns bore no love for Hitler. For one thing, Finland depended upon Germany for grain, raw materials and arms supplies during the war; otherwise the country would have been in even more dire straits than it already was. There was also much behind-the-scenes political activity which the author lets us in on.

In 1939, the Finns said no to Stalin; in 1944, they were finally able to say no to Hitler. Thus they survived as an independent nation. Apart from Great Britain and the Soviet Union, Finland was the only European country participating in the Second Wodd War that was not taken over, either by Germany or the Soviet Union. This 111-page book is a short but fascinating read, giving a glimpse of Finnish history we don't usually hear about. You'll find it in the nonfiction section, Call number, 947.103 Ta.

Since Finland's history is so often intertwined with that of Russia, the following might also interest you: INSIDE THE SOVIET ARMY, by Viktor Suvorov, c1982. This book is rather dated, but for anyone interested in what the Soviet Army was like and what it was like to be a part of it, it makes interesting reading. The author has now defected to the West and has felt free to write what he surely could not have done while in the Soviet Union. Call number: 947.085 Suo

Finlandia Gardens Habitat Recognition

We are pleased to announce that the FCA has just achieved official status with the **National Wildlife Federation** as a Certified Wildlife Habitat. Certification requires that a habitat provide four basic conditions: food- bearing plants and trees, cover for wildlife to be protected, places for wildlife to raise their young and a source of water. We offer all of these in Finlandia Gardens. An appropriate sign will soon be placed at the Center to show our designation.

Recently a blue heron has been observed in our natural area, an indication of the attractiveness of our property to wildlife

Also...members having garden tools or other garden items are encouraged to donate them to the Garden Club.

SENIOR HOUSING

One Contribution, Four Beneficiaries

Many FCA members have wondered why does the FCA Housing Corporation need donations. The annual reports of the FCA Housing Corporation show a substantial cash balance. However, the Housing Corporation assures you that the need still exists. During the year 2005 the Housing Corporation purchased the outstanding investments of all of the "for profit" limited partners in the Tapiola Village (phase I) project. In order to consummate the purchases, debenture bonds were sold. To avoid a change of ownership with the Housing Corporation being the sole owner, the ownership entity was retained. Instead of the "for profit" limited partners, the Finnish Center Association was offered the role as the sole limited partner in the existing limited partnership. A change in the ownership entity would have necessitated a change in the mortgage agreement, regulatory agreement and a number of other documents.

There is now a need to pay the interest and redemption costs on these debenture bonds. Three hundred bonds each having a cost of \$1,000.00 were sold. The bonds have a ten year term, but can be called for early redemption after the first year of ownership. The dividends (profits) received from the housing projects will be used for the interest and redemption payments.. Projecting the income and expense data of the projects and making assumptions as to what profits might be available, the bond program should be completed within its ten year term.

The Housing Corporation would like to accelerate the payoff time of these bonds. When this is accomplished, the funds received from the projects each year can then be used for other purposes, such as improving services for the residents and making residual funds available for the Housing Corporation. The Housing Corporation could be in a position to make part of its funds available for projects which would also benefit the Finnish Center Association. For example, the Housing Corporation could undertake a larger financial role towards making the gazebo a reality. If the entry canopy to the Finnish Center is desired, the Housing Corporation could possibly make a significant contribution for such a project.

These kind of expenditures would be possible when the bond obligations have been satisfied. Contributions made to the FCA Senior Citizens Housing Corporation are <u>tax-deductible</u> contributions, which are a benefit to the donor. The Housing Corporation obviously benefits by the elimination of its bond debts, the residents in Tapiola benefit by any project improvements made by the Housing Corporation and the Finnish Center Association could become a beneficiary of the Housing Corporation's financial participation in its projects. Get more mileage from your donations. Your contributions to the FCA Senior Citizens Housing Corporation will do it.
